PROACTIVE BOARD VS. REACTIVE BOARD

SELECTION OF THE DRB MEMBERS

- Establish at start of project
- Neutral
- Expertise
- Attorneys vs. technical professionals
- Other important attributes of DARB members
- How do you find DARB candidates?
- Training
- How do I break into the field?

SELECTION OF THE DRB MEMBERS

AAA DARB Rule 1.3

- Select from list furnished by AAA
- Parties consult in good faith to agree
- If no agreement, then party appointed and two select third
- All must be approved by both parties Key
- Challenges to board members decided by AAA
- Impasse AAA appoints
- Selection of replacement member if vacancy occurs

PERIODIC JOB SITE MEETINGS

DARB Rule 1.4

- Cornerstone of DARB process that differentiates it from all other ADR processes
- What is done at meetings?

DARB Rule 1.5B

- Benefits
- Can DARB really give different recommendation if you go to formal process?

DARB Rule 1.5C and AAA Hearing Procedures

- Request for hearing
- When and where
- Pre-hearing submission
- Presentation
- Attorneys
- Recommendations

DARB Rule 1.5(C)

- 14 days to accept or reject or become binding
- 7 days to seek clarification or reconsideration
- Contract determines whether recommendations are non-binding or binding
- If non-binding, contract will determine admissible or non-admissible
- Is one approach better?
